#### **MINUTES**

1. Reading of the Official Notice of the Meeting

Dr. Heather Lochnan, CSEM President, called the Annual General Meeting (AGM) to order at 8:07 pm. Notice of the AGM was emailed to members on August 27, September 17, October 20, October 26 and November 10. The notice and materials were also posted on the CSEM website. Quorum has been achieved for this meeting with 39 voting members present.

# 2. Approval of Agenda

The agenda was approved as submitted.

#### 3. Approval of the 2019 AGM Minutes

# 5. Secretary-Treasurer's Report

a. Financial Statements to May 31, 2020

Dr. Breay Paty, Secretary-Treasurer, presented the audited 2019-2020 financial statements (appended) showing an excess of revenue over expenses in the amount of \$6,917. #### b. Appointment of Auditors

# 6. Nominating Committee Report (report appended)

a. Review of Directors' Terms and Renewal Dr. Jean-Patrice Baillargeon, Past-President, presented the Nominating Committee report as appended. Directors Donna Vine and Ferhan Siddiqi have completed a first term as Council Directors and were invited to renew for a second three-year term.

### b. Appointment of CPD Chair

Dr. Céline Huot, CPD Chair, has completed her second term on Council. As per CSEM bylaw *51 Role of Officers*, the Nominating Committee recommends that Dr. Huot remain on Council as an Officer until the 2021 AGM. Dr. Huot's consistent leadership and expertise in this role is necessary to help ensure CSEM's successful reaccreditation in 2021 as an accredited provider with the Royal College of Physicians and Surgeons of Canada.

#### 7. Committee Reports

a. CPD Committee

Céline Huot, Chair, encouraged members to complete the Needs Assessment Survey to ensure the relevancy of CPD programs. The annual Knowledge Transfer Activities and a new and Evening of Science session will be offered in first quarter of 2021.



# Guidelines Committee Adam Millar, Chair, reported that the Committee reviewed and endorsed the Canadian Adult Obesity Clinical Practice Guidelines.

#### c. Awards Committee

Stephanie Kaiser, Chair, reported on a new multi-year research grant funded by the Thyroid Foundation of Canada and administered by CSEM. The award is \$50,000 per year for two years to support research in thyroid disease that impacts patient care. The Dr. Harvey Guyda Educator of the Year award and the Dr. Robert Volpé award were not offered this year due to the pandemic and virtual conference. No submissions were received for the Young Investigator award. The Dr. Fernand Labrie Research Fellowship grant was awarded to Dr. Cathy Sun, Ottawa.

d. Quality Improvement Committee
Ferhan Siddiqi, Chair, reported that the committee has been less active over past
six months. There was good QI content at the professional conference; CSEM
continues to participate in the Choosing Wisely Canada initiative.

#### 8. Executive Director's Report

Inika Anderson, Executive Director, presented CSEM's first ever Annual Report (appended). Membership increased this year from from 512 in 2019 to 534. A new membership category, Active – Recent Grad, is helping to transition recent graduates to become full-time members. The focus of the Society's work for the upcoming year will be a CDP needs assessment, re-accreditation with the Royal College, and strategic planning.
