CSEM's accomplishments over the past year include renewal of CSEM's status as an accredited provider of the Royal College of Physicians and Surgeons of Canada. CSEM achieved the full 8-year accreditation renewal thanks to the leadership of Dr. Céline Huot, CPD Chair (2018-2021) and Dr. Elizabeth Rosolowsky, CPD Chair (2021-present). CSEM added a second full-time employee in January 2022: Jennifer Lafreniere as a permanent Membership and Administrative Coordinator. CSEM's growth and success as a Society is due to the continued support of its members, dedication of Council and Committee volunteers, and strong staff management.

CSEM successful year can be contributed to four-and-a-half years of dedicated staff management. The Society is busy with accredited CPD activities, drug shortage advocacy with Health Canada, and strengthening partnerships. Notably, CSEM renegotiated its share of the revenues from the Diabetes Canada/CSEM Professional Conference resulting in a 19% share. Future goals for the Society include the addition of another staff person, resident recruitment and retention, completing a strategic plan, and acting as a host for the 2023 Vascular Congress.
